

**MINUTES OF MEETING
OF THE CYBER RISK COMMITTEE OF THE

A meeting of the Cyber Risk Committee (the "Committee") of The University of Texas/Texas A&M Investment Management Company ("UTIMCO" or the "Corporation") convened in Open Session on **March 12, 2024**, by means of video and telephone conference enabling all persons participating in the meeting to hear each other, at the offices of the Corporation, 210 West 7th Street, Suite 1700, Austin, Texas, said meeting having been called by the Committee Chair, Ray Rothrock ("Chair"), with notice provided to each member in accordance with the Corporation's Bylaws. Executive Session


